Notification for Empanelment of Service Providers for Bulk Waste Management in Bengaluru

BBMP invites application for Empanelment of service provider for **Processing** of Wet, Domestic hazardous waste (Bio medical, Sanitary waste etc), Green, E waste, C & D waste and **recycling** of Dry waste from Bulk waste Generators.

Eligibility Criteria & Conditions:

1. The service provider needs to have processing/ re-cycling facilities which is operational and functional for any of the specified type of waste.
2. It must be ensured that the procedure/process followed must be in complete compliance with the MSW Rules 2000.
3. Necessary clearances / sanctions / approvals from the competent authorities including but not limited to the following.
 - License from local authorities
 - Clearance from the Karnataka State Pollution Control Board (KSPCB) for the Wet, Domestic Hazardous, E-waste, C & D waste category
 - BESCOM clearance for power supply.
 - Any other clearance from State / Central government Authority, as required.
4. Should have Required Manpower and Vehicles for operation.
5. The successful Service provider needs to establish monitoring facility for tracking the data on collection transportation and processing from bulk generators. The same shall be shared with BBMP.
6. BBMP is not liable to provide any logistic or financial as a part of empanelment. The agencies are not entitled to make any claim on this account to BBMP.

The Interested service providers including the term expired and presently working service providers may submit the details as per the prescribed **Application form** which may be obtained from the office of Joint Commissioner (Health & SWM-1), 2nd Floor, Annex building, N.R Square, BBMP, Bangalore and also can be downloaded from the BBMP website (www.bbmp.gov.in) from 06/02/2016 to 20/02/2016.
